

### Are you up for the Reno Legacy Challenge?



Jack and Suzie Reno have called Winchester home for more than half a century – and they've spent a good deal of that time working to enhance the community, particularly in the area of health care.

The couple's tradition of philanthropy and volunteerism extends throughout their home town, and beyond. It includes founding the Winchester branch of a national nonprofit that provides academically talented students of color with expanded educational and career opportunities.

Jack and Suzie also have a long history of involvement with Winchester Hospital. Jack served as a member of the Winchester Hospital Board of Directors in the 1990s. Suzie was a founding committee member of Big Steps for Little People, a Winchester Hospital fundraising walk that benefited mothers and newborns.

In 2011, the hospital named them Philanthropists of the Year for their lead support of the new Center for Cancer Care, which houses the Reno Center for Medical Oncology.

On top of their philanthropic efforts for the hospital, Jack and Suzie also know firsthand the exceptional delivery of care Winchester Hospital provides. As patients, they recognize the importance of strengthening Winchester Hospital's future, and they want to challenge other grateful patients to give back as well.

Through the Reno Family Legacy Challenge, the family will match planned gifts to Winchester Hospital made before Sept. 30, 2016, up to \$100,000. The Reno family encourages community members to take advantage of this opportunity to have an even greater impact on health and wellness in Winchester and beyond.

# Four Gifts that Rise to the Challenge

Honor a loved one with a tribute gift through your will or trust.

This is a simple, meaningful way to leave an enduring statement about who you are and what is most important to you. Don't worry if you already have a will or trust in place. You don't have to redo anything. A simple addition to your existing documents is all it takes. You can leave a set amount, a percentage of the value of your estate after your heirs are cared for, or appreciated assets such as real estate, stock or artwork.

Contact your legal advisor and explain you would like to make a bequest to Winchester Hospital this fiscal year. Act soon because the challenge expires Sept. 30, 2016. Be sure to use the enclosed response form to tell us about your gift so we can recognize you and your loved ones.

#### Opt out of the voluntary tax!

Did you know that when you designate retirement assets to your heirs, taxes can slice away as much as 60 percent before your loved ones see a penny? But if you make Winchester Hospital the beneficiary of your retirement plan or IRA, the assets go to the hospital tax free! Consider leaving other, less taxburdened assets to your heirs by leaving your retirement plan or IRA to Winchester Hospital.

### Make Winchester Hospital a beneficiary with only a signature.

If you've ever opened a bank account, set up a retirement plan or purchased an insurance policy, chances are you completed a beneficiary designation form to indicate who will inherit those accounts. You may not realize you can also designate a charity as a beneficiary. It's the simplest planned gift you can make to meet the challenge.

Contact your bank or plan administrator and ask for a beneficiary designation form. This challenge expires Sept. 30, 2016. Remember to use the enclosed response form to tell us about your plans so we can count your gift as part of the challenge.

What is the deadline? The challenge expires on Sept. 30, 2016. Send in the response form soon so we can make sure your gift arrangements are in place in time to qualify.


- Name Winchester Hospital as a beneficiary.

German Language Unites Winchester Couple

For John and Paula Wells, German was more than a language they spoke and taught. It was what brought them together.

John grew up in Newton, Mass., and attended Harvard in the 1940s. Across the Atlantic, Paula Cullman was living in Berlin. In the early 1950s, Paula left the war-torn city and got a job at the German Consulate of Boston. John was teaching German at Tufts University at the time. Their paths crossed after Paula left the consulate and began doing administrative work for the Tufts University German Department. As "Frau Cullman," Paula left an indelible impression on all who met her – especially Professor Wells.

They married in 1978 and moved to Winchester. Over the next 28 years, they traveled the world frequently, but always turned to Winchester Hospital whenever they needed medical attention.

In appreciation for the exceptional care they received, John and Paula funded three charitable gift annuities with Winchester Hospital over the years. In 2007, Paula passed away. In her honor, John made a fourth gift annuity that made possible an expansion of a day surgery unit.
